#### **Conditions for passing the subject:**

The content of the Dissertation thesis – written work is (1) defending the written work of the examination, and (2) an oral exmination based on the syllabus approved by the doctoral board. The doctoral student will alply if he / she has 60 credits, including 40 credits for the Study part. An intern student can apply 18 month after starting his/her study (at earliest); an extern student can apply 24 month after starting his/her study (at earliest). For the Scientific part the student can get 20 credits.

Other conditions for granting consent to take the dissertation examination: obtaining the prescribed number of credits, handing over a printed study report with an overview of the credits obtained, and completing compulsory subjects (regulates the doctoral student's study plan). The dissertation examination is usually required no later than: (a) completion of the fifth semester of study for full-time doctoral students, (b) completion of the seventh semester of study for external form of doctoral students.

The written work for the dissertation exam has at least 1.5 author's sheets (30 pages) and contains in particular: the aim of the dissertation, the current state of knowledge (research) on the issue, analysis and justification of the methodological approach in solving the issue, outline of the theoretical foundations of the future solution, formulation of hypotheses and proposal of research strategy, contribution of the work, overview of the studied literature on the given issue, processing of partial results from the first year of solving the problem, structure of the future dissertation work (dissertation project).

#### **Results of education:**

Results of education: In the written work, the doctoral student is able to demonstrate skill in working with literature, mastery research methods and partial results of the dissertation. He is able to formulate theoretical background and goals of the dissertation. Can respond to questions and suggestions of the opponent and the trainer, argue and defend the written work. The written work for the dissertation exam and its defense and the oral exam are the content of the dissertation exam, for which the student will receive 10 credits.
